“Game on!” Walk for Life West Coast speaker David Daleiden responds to Planned Parenthood lawsuit

January 15, 2016 - On January 23, 2016 San Francisco will host the 12th Annual Walk for Life West Coast. One of the Walk’s featured speakers will be the founder of the Center for Medical Progress, David Daleiden. Mr. Daleiden, the man behind the series of videos exposing the abortion industry’s trafficking in the body parts of aborted children, was sued on January 14, 2016 by Planned Parenthood. In addition to damages, the lawsuit seeks to prevent Daleiden from ever launching another undercover investigation into Planned Parenthood’s activities—a classic example of the unconstitutional practice of prior restraint.

The lawsuit has certain aspects of ingratitude, since Daleiden’s videos have already encouraged Planned Parenthood to modify some of its objectionable practices. As the Washington Post reported on January 15, 2016 “Still, Cecile Richards, president of Planned Parenthood, publicly apologized for the tone of the comments of one official captured on tape, and the organization stopped accepting reimbursements for the fetal tissue it donates.”

Responding to news of the lawsuit, Daleiden said “Game on. I look forward to deposing all the CEOs, medical directors and their co-conspirators who participated in Planned Parenthood's illegal baby body parts racket.”

Daleiden will be represented by the Life Legal Defense Fund.

Walk for Life West Coast co-chair Eva Muntean said “Over the past year, all of America, including Americans who consider themselves ‘pro-choice’, have been shocked by revelations that the abortion industry has trafficked in the body parts of aborted babies. Even more shocking has been the revelation of the inhuman callousness with which abortion industry representatives view the practice, and their own victims. We, and we think most Americans, are proud of David for exposing these practices, and we are proud to have him as a speaker at the Walk for Life West Coast.”

The 2016 Walk for Life West Coast will begin at 12:30 PM with a rally in the city’s Civic Center Plaza. Following the rally, Walkers will march down Market Street to Justin Herman Plaza.

Founded in 2005 by a group of San Francisco Bay Area residents, the Walk for Life West Coast’s mission is to change the perceptions of a society that thinks abortion is an answer. Walk participants are expected from throughout the Bay Area and across the United States and Canada.
